## Background

According to the Objective 3.2e. Expand role and strengthen capacities of PHC facilities in delivering basic services, 1. Pilot PHC+ model in 5 selected PHC facilities, Pact selected five territorial communities to implement the project "PHC+ model". According to the Objective 3.3b. Facilitate access to essential health services, including MHPSS, 1. Support the implementation of mobile services to increase access to basic healthcare services in the current war context, Pact selected three territorial communities to implement the project "Integrated Support Through Multidisciplinary Mobile Teams". The quality and quantity of basic medical services directly depend on the provision of medical equipment to specialists of mobile multidisciplinary teams (hereinafter referred to as MMT) and PHC+ pilot medical facilities. Thus, Pact will be conducting a procurement of medical and rehabilitation equipment, and seeks for a consultant who will provide technical expertise during the process of preparing the procurement and assisting withing the process.

The consultant will be expected to develop technical specifications to conduct the procurement of medical and rehabilitation equipment. The consultant will also be expected to provide technical expertise during and after the procurement.

# Main purpose of consultancy/technical support

- To develop technical specifications for medical and rehabilitation equipment necessary to establish and perform functions of the multidisciplinary mobile teams and PHC+ pilot.
- To prepare Environmental Review Checklist (ERC) and Environmental Mitigation and Monitoring Plan (EMMP);
- To participate in the tender and procurement processes of the medical and rehabilitation equipment.
- To provide comments on submitted tender offers and evaluate them according to the established technical specifications.
