



**Request for Expression of Interest (EOI) from companies for road transportation of bulk wheat grain and bulk/breakbulk wheat flour within Ukraine**

**Background:**

The World Food Programme (WFP) is the world's largest humanitarian agency fighting hunger worldwide, delivering food assistance in emergencies and working with communities to improve nutrition and build resilience. Each year, WFP assists some 128 million people in around 120 countries.

**Scope of Service:**

The World Food Programme Ukraine wishes to invite interested parties and registered service providers **that can avail bulk grain and bulk/breakbulk flour trucks**, for a dedicated project/time period within Ukraine.

1. Certificate of opening a bank account.
2. Completed WFP Transport and Logistics Services questionnaire.
3. Financial statements of the commercial organization for at least the last 2-3 years (2021, 2022 and 2023) or confirmation of providing such statements within one month (including bank statements).
4. Certificate of state registration of a commercial organization.
5. Extract from the Unified Register of Legal Entities.
6. Certificate of registration of an enterprise that is a taxpayer (with VAT).
7. Certificate of payment of income tax for the last three years.
8. A valid business license.
9. Company Charter.
10. Letters of recommendation from three existing clients.

In responding to this EOI, submissions must be clearly labelled "*Expression of Interest - Transportation of bulk wheat grain and bulk/breakbulk wheat flour within Ukraine*" and submitted **no later than 18:00 on 21.08.2024**.

WFP may decide to convene a meeting with selected companies/applicants to verify provided information against the scope of the services required by WFP.

This EOI does not constitute a solicitation. WFP reserves the right to change or cancel the requirements at any time during this EOI. WFP also reserves the right to disregard an interested company/applicant from further consideration if the company/applicant is not deemed to conform to the above conditions. Thus, submitting a reply to this EOI does not automatically guarantee that the request will be considered for the roster of WFP service providers and be eligible to provide the required logistics services.
